In compliance with Article 108, of the Public Procurement Law ("The Official Gazette of the Republic of Serbia", No. 124/12, 14/15 and 68/15) and the Report of Bid Evaluation Commission No. 404-02-4/2016-05/8 dated 14 March 2016, the following

DECISION ON CONTRACT AWARD

is made for the Public Procurement of services – Procurement of maintenance services, technical support and worldwide support for the aircraft from Government Avio-Service fleet and procurement of spare parts and materials, as the most advantageous bid is selected Bid No. BSL0210085917, dated 10 February 2016 submitted by the Bidder JET AVIATION AG, Flughaffenstrasse, CH-4030 Basel, Switzerland. The contract for the Public procurement of the subject services will be concluded with the mentioned Bidder, pursuant to the accepted contract model.

This Decision should be published on the Internet page of the Government Avio Service www.aviosluzba.gov.rs, within three days from the day this decision was made.

I PUBLIC PROCUREMENT GENERAL DATA

- **5.Subject of Public procedure:** Procurement of services Procurement of maintenance services, technical support and worldwide support for the aircraft from Government Avio-Service fleet and procurement of spare parts and materials.
- **6. Data from Procurement Plan:** By Procurement Plan of the Government Avio-Service for the year 2015, No: 035-00-1/2016-01-1/2 from 06 January, 2016, the Public Procurement of maintenance services, technical support and worldwide support for the aircraft from Government Avio-Service fleet and procurement of spare parts and materials is foreseen. Financial resources for the subject public Procurement are provided by the Law on Budget of the Republic of Serbia for year 2016 ("Official Gazette of the Republic of Serbia, No. 103/15) section 3, chapter 3.14 Government Avio Service; Function 450; Economic classification 425 Current Repairs and Maintenance and 426 Material, Sources for funding 01- Income from budget.
- 7. Estimated value of the public procurement: 56.000.000,00 dinars.
- 8. Deviations from the Public procurement plan: none.

- **9. Bidder's general data:** full name of the Bidder: JET AVIATION AG; address and main office: Flughaffenstrasse, CH-4030 Basel, Switzerland; Registration number: 7-006149-09; Identification number TIN161059 VAT number 636-210; contact person: Mr Fabien Fuster; E-mail: fabien.fuster@jetaviation.ch.
- 10. Rejected bids, reasons for bids' rejection and offered price of the subject bids: there are no rejected bids.
- 11. In case only one bid was submitted, the opinion of Commission concerning the reasons which caused the submission of only one bid and proposed measures which should be taken in order to provide competition within the procedure: The only maintenance services provider that performs maintenance and repair services for the both aircraft types from the fleet of Government Avio Service in Europe is JET AVIATION AG, Basel City, Switzerland. Therefore, this company is the only Bidder in this Public Procurement procedure.

Besides that, the condition from the Tender documentation was that the services of technical maintenance and repair of the mentioned aircraft are performed in the territory of Europe, USA, Middle-East and Asia and the Bidder was obliged to prove that he has at least one (1) service center in Europe, USA, Middle-East, Asia, for maintenance checks on the aircraft Falcon 50 and Learjet 31A. This condition was also fulfilled only by the Bidder JET AVIATION AG, Basel – City, Switzerland.

- **12.** Name of the Bidder who was awarded the contract: JET AVIATION AG, Flughaffenstrasse, CH-4030 Basel, Switzerland, the Bid number BSL0210085917, dated 10 February 2016, timely submitted, proper and acceptable; offered price: **5.383.00 CHF**, at the middle exchange rate on the day of bid opening amounts **604.304,1928** dinars (middle exchange rate of CHF = 112,2616).
- 13. Criterion for selection of the most advantageous bid: the lowest offered price.

IIPUBLIC PROCUREMENT PROCEDURE, BID EVALUATION AND RANKING:

Pursuant to Article 32 of the Law on Public Procurements, the Invitation for bid submission for the Public procurement of services – "Procurement of maintenance services, technical support and worldwide support for the aircraft from Government Avio-Service fleet and procurement of spare parts and materials", 404-02-4/2016-05/4 dated 01 February 2016, was published on 01 February 2016 on the Public Procurement portal and the Internet page of the Procuring entity: www.aviosluzba.gov.rs.

Bid submission deadline, determined in the Invitation for bid submission, was 14 March 2016 until 13.00 o'clock.

Bid opening procedure was conducted immediately upon the expiry of the bid submission deadline, i.e. on 14 March, 2016. Bid opening procedure started at 13.30 and terminated on the same day at 14.10.

Commission for Public Procurement has determined that one bid was delivered to the address of Procuring entity within foreseen deadline, i.e. timely. That is the bid of the Bidder:

There were no untimely received bids.

The authorized bidder's representative nor other persons were present at the bid opening. Therefore, the Minutes on bid opening No. 404-02-4/2016-05/6 dated 14 March 2016, were submitted in accordance with Article 104, item 6 of the Law on Public Procurements.

On 14 March 2016, at 14:15 o'clock, the Commission composed of members: Jovanka Perušinović, Vladan Trifunović and Jelena Ognjanović performed a detailed review and expert evaluation of the bid and made a respective Minutes.

Commission's work was supported by Sofija Žmirić, English language translator. Commission established the following:

- that the Bidder JET AVIATION AG, Flughaffenstrasse, CH-4030 Basel, Switzerland, submitted the offer on 11 March 2016, at 13.00 by post services and therefore it has been concluded that the bid was timely delivered,
- that the bid and all annexes and evidences attached to the bid are submitted in English language, pursuant to the conditions from Tender documentation,
- that the bid contains all forms and evidences required by Tender documentation, as follows:
 - Form No. 1 Bid form; completed, certified and signed,
 - Form No. 2 Price breakdown form; completed, certified and signed,
 - Form No. 3 Bid preparation costs form, certified and signed,
 - Form No. 4 Statement of the independent bid; certified,
 - Form No. 5 -Bidder's general data form; completed, certified and signed
 - Form No. 6 Statement of the group member; not applicable,
 - Form No. 7 Group member's general data; not applicable
 - Form No. 8 Bidder's statement that he isnot participating with subcontractors, completed, certified and signed
 - Form No. 9 Statement on hiring a subcontractor; not applicable
 - Form No. 10 Subcontractor's general data; not applicable

and following evidences:

- 1.-Excerpt from the Registry for canton Basel- City dated 19 February 2016 as evidence that the company JET AVIATION AG, with registered office at Aeschengraben 26, 4051 Bazel City, Switzerland, was entered in the Company Register on 13 November 1967, for the first time.
- 2. Statement of legal advisers of the Company JET AVIATION AG, proving that the Bidder operates in accordance with the applicable regulations of Switzerland, i.e. that the Bidder and his legal representative have not been convicted of a criminal act as a part of organized criminal organization, of a criminal act against commerce, environment, giving or accepting bribe, committing fraud.
- **3.**Statement of the general manager and maintenance manager regarding impossibility to submit the certificate from Commercial Court or Magistrates, because such a certificate is not issued by the mentioned Swiss Courts. The Statement of legal advisers of the company JET

AVIATION AG dated 10 February 2016, it is proved that the bidder has not been prohibited from performing activity.

- **4.**Certificate issued on 24 February 2016 by Financial Department of Tax Administration for canton Basel-Stadt proving that the Bidder JET AVIATION AG, with registered office at Aeschengraben 26, 4051 Basel City, Switzerland, has settled all due taxes and other public taxes of canton Basel-Stadt, and that he has no outstanding debts regarding tax payments, as well.
- **5.1.** Approval certificate part 145 issued by FOCA-e (EASA member) proving that the Bidder JET AVIATION AG, with registered office at Aeschengraben 26, 4051 Basel City, Switzerland has fulfilled all conditions for performance of services that are subject of the public procurement. Pursuant to the afore mentioned, JET AVIATION AG possesses (APPROVAL CERTIFICATE PART 145) for:
 - aircraft (A1- aeroplane) FALCON 50 base and line maintenance,
 - aircraft (A1- aeroplane) LEARJET 31A base and line maintenance,
 - engine unit (B1- TURBINE) HONEYWELL TFE731.
- **5.2.** Document proving that the bidder JET AVIATION AGis certified as the authorized service center for the aircraft Falcon 50 by the aircraft manufacturer Dassault Aviation for the period from 2016 to 2020.
- **5.3.** Document proving that the bidder JET AVIATION AG is certified as the authorized service center for the aircraft Learjet 31A by the aircraft manufacturer Bombardier valid until 12 November 2016.
- **5.4.** Document proving that the bidder JET AVIATION AG is certified as the authorized Service center for TFE-731 engine units by the engine manufacturer Honeywell valid until 31 December 2017.
- **6.** The Bidder JET AVIATION AG has fulfilled the following additional conditions by submitting the respective evidences, whereas:
- **6.1.** In respect to the additional condition related to financial capacity, the Bidder submitted notification-evidence dated 10 February 2016, that the company JET AVIATION AG is a part of the business entity GENERAL DYNAMICS GROUP which operates within the New York Stock Exchange and that accordingly, the company JET AVIATION AG is not allowed to disclose any business results.

Evidence (1) regarding business activities is available on the official company site of GENERAL DYNAMICS GROUP: www.generaldynamics.com, where the information regarding integral business result can be viewed.

On the site wwwgeneraldynamics.com of the company GENERAL DYNAMICS GROUP, Commission has found financial results of the aviation group for the last three years, and they met the requirements.

Evidence (2) Certificate of the Bankruptcy Administration of the canton (Konkursamt des Kantons Basel-Stadt), dated 19 February, that the Bidder is not on the list of the business entities under the Bankruptcy.

- **6.2.** By his Statement dated 10 February 2016, the Bidder proved that:
- performed at least thirty (30) basemaintenance checks on theaircraft FALCON 50,
- performed at least ten (10) basemaintenance checks on theaircraftLEARJET 31A,
- performed at least twenty (20) major periodic inspection (MPI) within the maintenance of TFE731engine unit,

- performed at least five (5) Hot Section Inspections (HIS) of auxiliary power unit (APU) GTCP36.
- 7.1. Documents proving Bidder's technical capacity;

7.2. Documents proving Bidder's organizational, technical and personnel capacity with necessary licenses.

Commission has established that the bid number BSL0210085917 of the Bidder JET AVIATION AG, Flughaffenstrasse, CH-4030 Basel, Switzerland, dated 10 February 2016 is in compliance with all conditions of the Public Procurement Law and tender documentation and therefore acceptable.

Upon expert evaluation of bids, by applying the criterion of the lowest offered price, Commission has executed the ranking of proper and acceptable bids:

Pursuant to Article 108 of the Public Procurement Law and according to expert evaluation of the bid and performed ranking of the proper and acceptable bid by applying the criterion of the lowest offered price, Commission has proposed to the Procuring entity to make the decision on contract award and conclusion for the Public procurement – "Procurement of maintenance services, technical support and worldwide support for the aircraft from Government Avio-Service fleet and procurement of spare parts and materials" with the Bidder JETAVIATION AG, Flughaffenstrasse, CH-4030 Basel, Switzerland, whose Bid No. BSL0210085917 dated 10 February 2016, has been evaluated as proper and acceptable.

Pursuant to Article 108, paragraph 5 of the Public Procurement Law, the Procuring Entity is bound to publish the Decision on contract award on the Public Procurement portal and the Internet page of the Procuring entity www.aviosluzba.gov.rs, within three days from the day of Decision.

The Decision was made according to the wording thereoff.

LEGAL REMEDY: The time limit for submitting a request for protection of rights is 10 days from the day of receipt of decision.
