In compliance with Article 108, of the Public Procurement Law ("The Official Gazette of the Republic of Serbia", No. 124/12, 14/15 and 68/15) and the Report of Bid Evaluation Commission No. 404-02-27/2015-01/9 dated 25 September 2015, the following

#### **DECISION ON CONTRACT AWARD**

is made for the Public Procurement of services – "Additional maintenance services, technical support and worldwide support for the aircraft from Government Avio-Service fleet and procurement of spare parts and materials", as the most advantageous bid is selected Bid Number: BSL0914152833 dated 14 September 2015, of the Bidder JET AVIATION AG, Flughaffenstrasse, CH-4030 Basel, Switzerland. The contract for the Public procurement of the subject services will be concluded with the mentioned Bidder.

This Decision will be published on the Public Procurement Portal and on the Internet page of the Procuring entity <a href="www.aviosluzba.gov.rs">www.aviosluzba.gov.rs</a>, within three days from the day this decision was made.

### Explanation

By decision No: 404-02-27/2015/01 dated 09 September 2015, a Contract award for the public procurement of services was carried out in the negotiated procedure without prior publication of invitation to submit bid, according to the Article 36, paragraph 1, item 5, sub-item 1 of the Public Procurement Law.

#### I PUBLIC PROCUREMENT GENERAL DATA

7. Rejected bids, reasons for bids' rejection and offered price of the subject bids: there are no rejected bids.

## II PUBLIC PROCUREMENT PROCEDURE, BID EVALUATION AND RANKING:

By Decision No. 404-02-27/2015-01 dated 09 September, 2015, was initiated the Public procurement of services – Additional maintenance services, technical support and worldwide support for the aircraft from Government Avio-Service fleet and procurement of spare parts and materials, pursuant to Article 36, paragraph 1, item 5, sub-item 1 of the Public Procurement Law.

The announcement on initiation of negotiated procedure without prior publication of invitation to submit bid No. 404-02-27/2015-01-4 dated 14 September 2015 was submitted to the interested person, i.e. the original Bidder who was awarded a Contract for provision of Maintenance services, technical support and worldwide support for the aircraft from Government Avio-Service fleet and procurement of spare parts and materials.

Simultaneously, the announcement on initiation of negotiated procedure was published on the Public Procurement Portal and on the Internet page of the Procuring entity <a href="https://www.aviosluzba.gov.rs">www.aviosluzba.gov.rs</a>, on 14 September 2015 and therefore all conditions set forth in Article 36, paragraph 7 and Article 57 of the PPL have been met.

Determined Bid submission deadline: 24 September 2015 until 12.00 o'clock.

Bid opening procedure was conducted immediately upon the expiry of the bid submission deadline, i.e. on 24 September, 2015 at 12.30 and terminated on the same day at 13.10. The respective Minutes were taken out.

Commission for Public Procurement has determined that the bid of the following Bidder was delivered to the address of Procuring entity within foreseen deadline, i.e. timely:

There were no untimely received bids.

The authorized bidder's representative nor other persons were present at the bid opening. The Minutes on bid opening were submitted in accordance with Article 104, paragraph 6 of the Public Procurements Law.

After the Bid opening, performed on 24 September 2015, Commission reviewed the bid and made expert evaluation. The respective Minutes were also taken.

In the course of detailed review and expert evaluation of the bid, the Commission established that the Bid No. BSL0914152833 dated 14 September 2015, submitted by the Bidder JET AVIATION AG, Flughaffenstrasse, CH-4030 Basel, Switzerland, has been evaluated as correct, proper and acceptable because it complies with all conditions of Public Procurement Law and Tender documentation.

During negotiations, Commission established that the authorized Bidder's representative was not present and therefore, the final offered price in the negotiated procedure No. P 04/2015 for provision of Additional maintenance services, technical support and worldwide support for the aircraft from Government Avio-Service fleet and procurement of spare parts and materials amounts: 36.297 CHF or 3.976.394,4252 dinars, at the middle exchange rate of the National Bank of Serbia on the day of 24 September 2015 (middle exchange rate of CHF = 109,5516). The respective Minutes were also taken out.

According to the aforementioned, the Commission for Public Procurement No. P-04/2015 has made an expert evaluation report No. 404-02-27/2015-01-8 dated 25 September 2015. In that report, Commission proposed to the Procuring entity to make decision on contract award for the Public procurement – Additional services, technical support and worldwide support for the aircraft from Government Avio-Service fleet and procurement of spare parts and materials and conclude the contract with the Bidder JET AVIATION AG, Flughaffenstrasse, CH-4030 Basel, Switzerland.

Based on that and on the expert evaluation report No. 404-02-27/2015-01-8 dated 25 September 2015, in which the Commission proposed to the Procuring entity to make the decision on contract award for the Public procurement with the Bidder JET AVIATION AG, Flughaffenstrasse, CH-4030 Basel, Switzerland, whose Bid No. BSL0914152833 dated 14 September 2015 was evaluated as timely, adequate and acceptable within the Public Procurement Procedure, it was decided as in the wording of the Decision.

**LEGAL REMEDY:** The time limit for submitting a request for protection of rights to appeal against this Decision is 10 days from the day the Decision on contract award is published on the Public Procurement Portal.
